NY Rising Housing Program Permits

Revised September 12, 2017

NY Rising Housing Program (applies to all Programs)

Whether you plan to repair your existing property or rebuild a new one, your project will most likely require permits. Building permits are issued by the local building department or authority having jurisdiction over construction activities. The work performed on your property must be inspected during, and/ or after construction, as determined by the oversight building department. These inspections verify that the work is performed to local building codes. The NY Rising Housing Program (the Program) requires you to submit these permits in order to receive your final payment.

Some examples of work requiring permits are:

- Foundation/Elevation
- Framing
- Electrical
- Plumbing
- Mechanical/HVAC

Additional certificates required:

- **Elevation Certificate** – You may be required to submit a certificate prior to elevation and an updated certificate after elevation work is complete. This document is obtained by your design professional.
- **Certificate of Occupancy (COO)** – Your building department will issue this certificate once your property passes local building code inspection. A COO is required for substantially improved and new construction.
- **Certificate of Completion** – If you repaired your existing property and the work did not require a permit from your local building department, this document is acceptable in lieu of a Certificate of Occupancy. This document is obtained with the assistance of your design professional.
- **Municipal Inspection Report** – You should request a municipal inspection report or receipt at the time of visit by the local municipality, where applicable.
