

SIXTH AMENDMENT  
TO  
CONTRACT FOR SERVICES

THIS SIXTH AMENDMENT to the Contract for Services dated January 9, 2015, and made effective October 23, 2014, is made and entered into December 13, 2019, (the "Sixth Amendment"), between Jacobs Project Management Co., having an office located at Two Penn Plaza, Suite 0603, New York, New York 10001 ("Contractor"), and the HOUSING TRUST FUND CORPORATION, having its principal office at 38-40 State Street, Albany, New York 12207 ("HTFC").

WITNESSETH:

WHEREAS, Contractor was a successful bidder pursuant to a request for proposals issued by HTFC on July 1, 2014 (the "RFP"); and

WHEREAS, HTFC and Contractor entered into a Contract for Services (the "Agreement") on January 9, 2015, and made effective October 23, 2014, pursuant to which Contractor provides certain services in support of HTFC's administration of the State of New York's Community Development Block Grant-Disaster Recovery ("CDBG-DR") program; and

WHEREAS, HTFC's Governor's Office of Storm Recovery ("GOSR") is specifically tasked with administering the State of New York's CDBG-DR program and therefore oversees and administers this particular Agreement; and

WHEREAS, Contractor's Total Fee in the Contract for Services dated January 9, 2015 and made effective October 23, 2014, totaled \$1,000,000.00; and

WHEREAS, HTFC and Contractor entered into the First Amendment to the Agreement on April 27, 2015 which increased the Total Fee to \$5,000,000.00 with no change in Term; and

WHEREAS, HTFC and Contractor entered into the Second Amendment to the Agreement on November 5, 2015 which extended the Term until October 22, 2016 with no change in Total Fee; and

WHEREAS, HTFC and Contractor entered into the Third Amendment to the Agreement on October 28, 2016 which extended the Term until October 22, 2017 with no change in Total Fee; and

WHEREAS, HTFC and Contractor entered into the Fourth Amendment to the Agreement on October 2, 2017 which extended the Term until March 31, 2018 and increased the Total Fee to \$5,600,000.00; and

WHEREAS, HTFC and Contractor entered into the Fifth Amendment to this Agreement on January 3, 2018 which extended the Term until March 31, 2019 and increased the Total Fee to \$7,300,000.00; and

WHEREAS, HTFC wishes to obtain additional services from Contractor that are within the scope of services sought under the RFP and provided by Contractor under the Agreement; and

WHEREAS, HTFC seeks to extend the Term through March 31, 2020; and

WHEREAS, HTFC/GOSR and Contractor desire to amend the Agreement by means of this Sixth Amendment in order to extend the Term to March 31, 2020 to allow Contractor to continue to provide services;

NOW, THEREFORE, pursuant to and in consideration of the above, and other mutual covenants and obligations herein contained, it is

STIPULATED AND AGREED as follows:

1. The first sentence of Section 4 of the Agreement, entitled "Period of Agreement," is hereby deleted and replaced with the following: "This Agreement shall commence as of the Effective Date and shall terminate on March 31, 2020."
2. All other terms and conditions, including appendices, attachments, exhibits, riders and Letter Agreements to the Agreement are hereby continued in full force and effect as though set forth herein.
