

SIXTH AMENDMENT
TO
CONTRACT FOR SERVICES

THIS SIXTH AMENDMENT to the Contract for Services dated January 9, 2015, and made effective October 23, 2014, is made and entered into May 24, 2019 (the "Sixth Amendment"), between Hill International, Inc. having an office located at One Penn Plaza, 34th Floor, Suite 3415, New York, NY 10119 ("Contractor"), and the HOUSING TRUST FUND CORPORATION, having its principal office at 38-40 State Street, Albany, New York 12207 ("HTFC").

WITNESSETH:

WHEREAS, Contractor was a successful bidder pursuant to a request for proposals issued by HTFC on July 1, 2014 (the "RFP"); and

WHEREAS, HTFC and Contractor entered into a Contract for Services (the "Agreement") on January 9, 2015, and made effective October 23, 2014, pursuant to which Contractor provides certain services in support of HTFC's administration of the State of New York's Community Development Block Grant-Disaster Recovery ("CDBG-DR") program; and

WHEREAS, HTFC's Governor's Office of Storm Recovery ("GOSR") is specifically tasked with administering the State of New York's CDBG-DR program and therefore oversees and administers this particular Agreement; and

WHEREAS, Contractor's Total Fee in the Agreement dated January 9, 2015 totaled \$500,000.00; and

WHEREAS, HTFC and Contractor entered into a First Amendment to the Agreement on April 20, 2015 which increased the Total Fee to \$2,500,000.00; and

WHEREAS, HTFC and Contractor entered into a Second Amendment to the Agreement on August 12, 2015, which increased the Total Fee to \$5,471,626.00 and extended the Term to October 22, 2016; and

WHEREAS, HTFC and Contractor entered into a Third Amendment to the Agreement on July 11, 2016, which increased the Total Fee to \$7,966,968.48 and extended the Term to February 28, 2017; and

WHEREAS, HTFC and Contractor entered into a Fourth Amendment to the Agreement on March 10, 2017, which increased the Total Fee to \$13,716,968.48 and extended the Term to March 31, 2018; and

WHEREAS, HTFC and Contractor entered into a Fifth Amendment to the Agreement on May 17, 2018, which extended the Term of the Agreement to March 31, 2019; and

WHEREAS, GOSR wishes to obtain additional services from Contractor that are within the scope of services sought under the RFP and provided by Contractor under the Agreement; and

WHEREAS, GOSR seeks such additional services in the amount of \$500,000.00, thereby increasing the Agreement's Total Fee to the amount of \$14,216,968.48; and

WHEREAS, GOSR seeks to extend the Term to March 31, 2020; and

WHEREAS, HTFC/GOSR and Contractor wish to amend the Agreement by means of this Sixth Amendment in order to increase the Total Fee and to extend the Term to allow Contractor to continue to provide services;

NOW, THEREFORE, pursuant to and in consideration of the above, and other mutual covenants and obligations herein contained, it is

STIPULATED AND AGREED as follows:

1. The second sentence of Section 2(a) of the Agreement is hereby deleted and replaced with the following: "Contractor agrees that in no event will HTFC pay the Contractor more than \$14,216,968.48 ("Total Fee") for the Services under all Task Orders under this Agreement."
2. The first sentence of Section 4 of the Agreement, entitled "Period of Agreement," is hereby deleted and replaced with the following: "This Agreement shall commence as of the Effective Date and shall terminate on March 31, 2020."
3. Subsection 2 of Exhibit B to the Agreement, entitled "Fee Schedule and Rates for CM Support Services Contracts", is hereby deleted and replaced with the following: "Total Compensation for services under this contract shall not exceed \$14,216,968.48."

4. All other terms and conditions, including appendices, attachments, exhibits, riders and Letter Agreements to the Agreement are hereby continued in full force and effect as though set forth herein.
