

SIXTH AMENDMENT  
TO  
CONTRACT FOR SERVICES

THIS SIXTH AMENDMENT to the Contract for Services dated January 16, 2014, is made and entered into December 23 2016 (the "Sixth Amendment") and made effective January 1, 2017 between Hunt, Guillot & Associates, having an office located at 603 Reynolds Drive, Ruston, Louisiana 71270 ("Contractor"), and the HOUSING TRUST FUND CORPORATION, having its principal office at 38-40 State Street, Albany, New York 12207 ("HTFC").

WITNESSETH:

WHEREAS, Contractor was a successful bidder pursuant to a request for proposals issued by HTFC on July 1, 2014 (the "RFP"); and

WHEREAS, HTFC and Contractor entered into a Contract for Services (the "Agreement") on January 16, 2015 and made effective October 23, 2014, pursuant to which Contractor provides certain services in support of HTFC's administration of the State of New York's Community Development Block Grant-Disaster Recovery ("CDBG-DR") program; and

WHEREAS, HTFC's Governor's Office of Storm Recovery ("GOSR") is specifically tasked with administering the State of New York's CDBG-DR program and therefore oversees and administers this particular Agreement; and

WHEREAS, Contractor's Total Fee in the Contract for Services dated January 16, 2015 totaled \$5,000,000.00; and

WHEREAS, HTFC and Contractor entered into a First Amendment to the Agreement on May 15, 2015 which increased the Total Fee to \$6,250,000.00; and

WHEREAS, HTFC and Contractor entered into a Second Amendment to the Agreement on August 31, 2015 which increased to Total Fee to \$11,200,000.00; and

WHEREAS, HTFC and Contractor entered into a Third Amendment to the Agreement on December 22, 2015 which increased the Total Fee to \$15,962,500.00; and

WHEREAS, HTFC and Contractor entered into a Fourth Amendment to the Agreement on February 22, 2016 which increased the Total Fee to \$22,093,820.00; and

WHEREAS, HTFC and Contractor entered into a Fifth Amendment to the Agreement on May 20, 2016 which increased the Total Fee to \$26,856,147.20; and

WHEREAS, GOSR wishes to obtain additional services from Contractor that are within the scope of services sought under the RFP and provided by Contractor under the Agreement; and

WHEREAS, GOSR seeks such additional services which will extend the Term until May 31, 2018 without altering the Total Fee; and

WHEREAS, HTFC/GOSR and Contractor desire to amend the Agreement by means of this Sixth Amendment in order to extend the Term to allow Contractor to perform additional services;

NOW, THEREFORE, pursuant to and in consideration of the above, and other mutual covenants and obligations herein contained, it is

STIPULATED AND AGREED as follows:

1. The first sentence of Section 4 of the Agreement is hereby deleted and replaced with the following: "The Agreement shall commence as of the Effective Date and shall terminate on May 31, 2018."
2. All other terms and conditions, including appendices, attachments, exhibits, riders and Letter Agreements to the Agreement are hereby continued in full force and effect as though set forth herein.
