

FIRST AMENDMENT
TO
DEMOLITION AGREEMENT

THIS FIRST AMENDMENT to the Demolition Agreement dated November 6, 2014, is made and entered into September 28, 2015 (the "First Amendment") between United Industries and Construction Corporation, having an office located at 2 Rector Street, Suite 11, New York, New York 10006 ("Contractor"), and the HOUSING TRUST FUND CORPORATION, having its principal office at 38-40 State Street, Albany, New York 12207 ("HTFC").

WITNESSETH:

WHEREAS, Contractor was a successful bidder pursuant to a request for proposals issued by HTFC on September 24, 2014 (the "RFP"); and

WHEREAS, HTFC and Contractor entered into a Demolition Agreement (the "Agreement") on November 6, 2014 and made effective September 26, 2014, pursuant to which Contractor provides certain services in support of HTFC's administration of the State of New York's Community Development Block Grant-Disaster Recovery ("CDBG-DR") program; and

WHEREAS, HTFC's Governor's Office of Storm Recovery ("GOSR") is specifically tasked with administering the State of New York's CDBG-DR program and therefore oversees and administers this particular Agreement; and

WHEREAS, HTFC and Contractor's Contract Price in the Agreement dated November 6, 2014 totaled \$57,900.00; and

WHEREAS, GOSR wishes to obtain additional services from Contractor that are within the scope of services sought under the RFP and provided by Contractor under the Agreement; and

WHEREAS, GOSR seeks such additional services in the amount of \$7,133.00, thereby increasing the Contract Price to the amount of \$65,033.00; and

WHEREAS, HTFC/GOSR and Contractor desire to amend the Agreement by means of this First Amendment in order to increase the Contract Price to allow Contractor to perform additional services;

NOW, THEREFORE, pursuant to and in consideration of the above, and other mutual covenants and obligations herein contained, it is

STIPULATED AND AGREED as follows:

1. The "Contract Price" of \$57,900.00 as stated in Section C of Schedule D to the Agreement, entitled "Project Addendum Terms and Conditions," is hereby deleted and replaced with \$65,033.00.
2. All other terms and conditions, including appendices, attachments, exhibits, riders and Letter Agreements to the Agreement are hereby continued in full force and effect as though set forth herein.
